- O. Bidders with an Experience Modification Rate (EMR) greater than 1.0 may not be considered for contract award.
- P. The successful bidder will be required to enter into a contract with Midland Public Schools on the AIA Document A132 Standard Form of Agreement between Owner and Contractor, Construction Manager as Adviser, 2009 Edition.
